THIS IS HOW IT WORKS

2. Each set of CHALLENGE CARDS reminds you to complete health-related challenges during the calendar year; these are probably things that you are already doing! Completion of each challenge and submission of the corresponding CHALLENGE CARDS allows your name to be entered into the KBA Benefits Trust Wellness Program drawings. This provides you with four opportunities to be entered!
3. In order to participate you MUST complete the 1st CHALLENGE CARD **by April 1, 2019**.
4. Once the 1st CHALLENGE CARD is completed, complete and submit your CHALLENGE CARD entries for one, or all, of the remaining Challenges, in any order, at any time during 2019!
5. Once you have completed a Challenge, attach sufficient postage and return the completed CHALLENGE CARD(S) to the address provided. Each CHALLENGE CARD is designed to be returned as a postcard, or all may be returned at once in an envelope addressed to KBA Benefits Trust, as indicated on the CHALLENGE CARDS.
